STORAGE AND DISPOSAL

Store in the closed, original container in a cool, well-ventilated area. DO NOT store for prolonged periods in direct sunlight. DO NOT contaminate seed, feed or foodstuff. DO NOT re-use container for any purpose.

Triple or preferably pressure rinse containers before disposal. Add rinsings to spray tank. DO NOT dispose of undiluted chemicals on-site. If recycling, replace cap and return clean containers to recycler or designated collection point. If not recycling, break, crush, or puncture and bury empty containers in a local authority landfill. If no landfill is available, bury the containers below 500 mm in a disposal pit specifically marked and set up for this purpose clear of waterways, desirable vegetation and tree roots. Empty containers and product should not be burnt.

For refillable containers, empty contents fully into application equipment. Close all valves and return to point of supply for refill or storage.

SAFETY DIRECTIONS

Will irritate eyes and may irritate the nose and throat. Repeated exposure may cause allergic disorders. Avoid contact with eyes and skin. When opening the container, preparing spray and using the prepared spray, wear cotton overalls buttoned to the neck and wrist (or

equivalent clothing) and elbow-length PVC or nitrile gloves and face shield or goggles. If product in eyes, wash it out immediately with water. Wash hands after use. After each day's use, wash gloves, face shield or goggles and contaminated clothing.
