In the event of a major spill, prevent spillage from entering drains or water courses.

Stop leak if safe to do so and absorb spill with sand, earth, vermiculite or some other absorbent material. Collect the spilled material and place into a suitable container for disposal. Wash spill area with hard water detergent.
