#### **MIXING**

- Fill vat 60-80% full with clean water BEFORE adding Atrazine 900 WG. Begin agitating vat contents vigorously and continue agitating during entire mixing and spraying operations.
- Pour required amount of Atrazine 900 WG STEADY into vat. Allow vigorous bypass agitation to completely disperse product. DO NOT dump product into vat all at once.
- After adding required quantity of Atrazine 900 WG and obtaining COMPLETE DISPERSION, continue to fill vat to desired level for spraying. Thorough agitation of the spray liquid should continue during the entire spraying operation.

N.B Spray solution should NOT be left standing in the vat or spray boom lines overnight.

#### STORAGE AND DISPOSAL

Store in the closed, original container in a dry, cool, well-ventilated area out of direct sunlight. Shake bag contents into spray tank until the bag is empty. Single rinse plastic bag before disposal. Add rinsings to spray tank. Do not dispose of undiluted chemicals onsite. Puncture or shred and deliver empty packaging for appropriate disposal to an approved waste management facility. If an approved waste management facility is not available, bury the empty packaging 500 mm below the surface in a disposal pit specifically marked and set up for this purpose clear of waterways, desirable vegetation and tree roots, in compliance with relevant Local, State or Territory government regulations. DO NOT burn empty containers or product.

## SAFETY DIRECTIONS

Avoid contact with eyes and skin. DO NOT inhale dust or spray mist. When preparing spray and using the prepared spray wear elbow length PVC gloves. After use and before eating, drinking or smoking, wash hands, arms and face thoroughly with soap and water. After each day's use wash gloves.
