#### STORAGE AND DISPOSAL

Store in the closed, original container in a dry, cool well-ventilated area out of direct sunlight. Protect from frost. Triple, or preferably pressure rinse containers before disposal. Add rinsings to spray tank. DO NOT dispose of undiluted chemicals on-site. If recycling, replace cap and return clean containers to recycler or designated collection point. If not recycling, break, crush or puncture and deliver empty packaging to an approved waste management facility. If an approved waste management facility is not available bury the empty packaging 500 mm below the surface in a disposal pit specifically marked and set up for this purpose clear of waterways, desirable vegetation and tree roots, in compliance with relevant Local, State or Territory government regulation. Do not burn empty containers or product.

#### SAFETY DIRECTIONS

Harmful if swallowed. Will irritate the eyes and skin. When preparing spray and using the prepared spray, wear cotton overalls buttoned to the neck and wrist, washable hat, elbow-length PVC gloves and face shield or goggles.
