STORAGE AND DISPOSAL

Store in the closed, original container in a cool, well-ventilated area away from children, animals, food, feedstuffs, insecticides, seed and fertilisers. DO NOT store for prolonged periods in direct sunlight.

For Non-Refillable Containers: Triple or preferably pressure rinse containers before disposal. Add rinsings to spray tank. DO NOT dispose of undituted chemicals on-site. If recycling, replace cap and return clean container to recycler or designated collection point. If not recycling, break, crush or puncture and bury empty containers in a local authority landfill. If not available, bury the containers below 500 mm in a disposal pit specifically marked and set up for this purpose clear of waterways, desirable vegetation and tree roots. Empty containers and product should not be burnt.

For Refillable Containers: Storage must be secure so that contents cannot be tampered with. All locks and/or seals must be in order. If locks or seals are broken prior to initial use then the integrity of this product cannot be assured. If this occurs FARMALINX Pty Ltd should be advised immediately. Empty contents fully into application equipment. Close all valves and return to point of supply for refill or storage.
