**STORAGE AND DISPOSAL:** KEEP OUT OF REACH OF CHILDREN. Store in the closed, original container in a cool, well ventilated area. Do not store for prolonged periods in direct sunlight. Triple or preferably pressure rinse containers before disposal. Add rinsings to spray tank. Do not dispose of undiluted chemicals on site.
