Farmalinx Techdeck Penetrant is a highly effective wetter/spreader/penetrant. It is effective with most agricultural chemicals unless otherwise stated on label.

While Techdeck Penetrant has been proven to be a highly efficient surfactant, timing, weather conditions, method of application, and/or mixture with other chemicals not specifically recommended are beyond the control of the seller. Therefore, the user should carefully observe spray deposits, rate efficiencies, compatibilities and effectiveness in initial applications and adjust the adjuvant rate accordingly.

MIXING INSTRUCTIONS:

- Mix pesticide product with water when tank is about 30% full
- Then when tank is nearly full add Techdeck Penetrant
- Complete filling tank

PROTECTION OF WILDLIFE, FISH, CRUSTACEANS AND ENVIRONMENT:

Do not contaminate streams, rivers or waterways with chemical or used containers.

STORAGE AND DISPOSAL:

KEEP OUT OF REACH OF CHILDREN. Store in the closed, original container in a cool, well ventilated area. Do not store for prolonged periods in direct sunlight. Triple or preferably pressure rinse containers before disposal. Add rinsings to spray tank. Do not dispose of undiluted chemicals on site. If recycling, replace cap and return clean containers to recycler or designated collection point. If not recycling, break, crush, or puncture and deliver empty packaging to an approved waste management facility. If an approved waste management facility is not available bury the empty packaging 500mm below the surface in a disposal pit specifically marked and set up for this purpose clear of waterways, desirable vegetation and tree roots. Do not burn empty containers or product.

Keep out of reach of children. Do not get on skin or on clothing. Causes eye irritation. Do not get in eyes. Harmful if swallowed. Avoid breathing vapour or mist. Avoid using product in a manner as to directly, or through drift, expose workers or other persons. Always follow the precautionary statements on the label of the pesticide(s) that are to be used with Techdeck Penetrant.

Applicators and other handlers must wear goggles or a facial splash shield; chemical resistant gloves, such as nitrile rubber > 14 mils or neoprene rubber > 14 mils; coveralls or long sleeved shirt and long pants; shoes plus socks and mists filtering respirator. After use and before eating, drinking or smoking, wash hands, arms and face thoroughly with soap and water. After each day's use wash goggles or face shield, gloves and any contaminated clothing.
