## STORAGE AND DISPOSAL

DO NOT store near feedstuffs, fertilisers or seed. Store in the closed, original container in a cool, well-ventilated area. DO NOT store for prolonged periods in direct sunlight.

**For Non-Refillable Containers:** Triple or preferably pressure rinse containers before disposal. Add rinsings to spray tank. DO NOT dispose of undiluted chemicals on site. If recycling, replace cap and return clean containers to recycler or a designated collection point. If not recycling, break, crush or puncture and bury empty containers in a local authority landfill. If no landfill is available, bury the containers below 500 mm in a disposal pit specifically marked and set up for this purpose, clear of waterways, desirable vegetation and tree roots. Empty containers and product should not be burnt.

**For Refillable Containers:** Storage must be secure so that contents cannot be tampered with. All locks and/or seals must be in order. If locks or seals are broken prior to initial use then the integrity of this product cannot be assured. If this occurs FARMALINX Pty Ltd should be advised immediately. Empty contents fully into application equipment. Close all valves and return to point of supply for refill or storage.

## SMALL SPILL MANAGEMENT

Wear protective equipment (See SAFETY DIRECTIONS). Apply absorbent material such as earth, sand, clay granules or cat litter to the spill. Sweep up material for disposal when absorption is completed and contain in a refuse vessel for disposal. (See STORAGE AND DISPOSAL section). If necessary, wash the spill area with an alkali detergent and water and absorb as above, the wash liquid for disposal.

## SAFETY DIRECTIONS

Harmful if swallowed. Will irritate the eyes and skin. Avoid contact with eyes and skin. When preparing spray, wear cotton overalls buttoned to the neck and wrists and a washable hat, elbow-length chemical resistant gloves and face shield or goggles. If the product in eyes, wash it out immediately with water. Wash hands after use. After each day's use, wash face shield or goggles and contaminated clothing.
